- 3) The actual Base TER charged to the scheme may be lower than the disclosed TER, on account of investments in bank fixed deposits, AMC's investments in scheme, investments by other schemes of Union Mutual Fund etc. on which Management Fee is not charged.
- 4) Any increase or decrease of Assets Under Management (AUM) which causes the TER to rise or fall as per the slab structure is not considered for computation of Base TER changes.
